








Figure 1. Output Characteristics




Figure 3. Drain-to-Source On Resistance vs.

Drain Current and Gate Voltage




Figure 2. Transfer Characteristics




Figure 4. Body Diode Forward Voltage vs.

Source Current and Temperature




Figure 5. Capacitance Characteristics




Figure 7. Normalized Breakdown Voltage vs.

Junction Temperature




Figure 9. Maximum Safe Operating Area for OP3710A




Figure 6. Gate Charge Characteristics




Figure 8. Normalized On Resistance vs.

Junction Temperature




Figure 10. Maximum Continuous Drain Current vs.

Case Temperature




Figure 11. Maximum Effective Transient Thermal Impedance, Junction-to-Case for OP3710A




Figure 12. Gate Charge Test Circuit & Waveform




Figure 13. Resistive Switching Test Circuit & Waveforms





Figure 14. Unclamped Inductive Switching Test Circuit & Waveforms






Figure 15. Peak Diode Recovery dv/dt Test Circuit & Waveforms (For N-channel)
