
### **Typical Inductance vs. Current Characteristics:**







# **Typical Temperature Rise vs. Current Characteristics:** Temperature Rise [K]

#### **Product specific:**

#### Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.


#### Packaging:
